NOTICE OF INTENT TO AWARD A CONTRACT WITHOUT ENGAGING IN A STANDARD PROCUREMENT PROCESS

The Purchasing Division of Support Services is publishing this notice pursuant to the Utah Procurement Code. The Conducting Procurement Unit submitted this form to Purchasing claiming that it intends to award a contract without competition if it is determined by Purchasing, in writing, that:

- there is only one source for the procurement item;
- transitional costs are a significant consideration in selecting a procurement item; or
- the award of a contract is under circumstances, described in rules adopted by the applicable rulemaking authority, that make awarding the contract through a standard procurement process impractical and not in the best interest of the procurement unit.

Achieve3000 is the only provider of these services, each of which utilizes proprietary, patented technology (USPTO 8,714,986 and 9,652,993), copyrighted materials, trade secrets and source code that are, in various parts, either owned by Achieve3000 or licensed to Achieve3000. As a result, these services may be utilized only with the permission of Achieve3000.

Achieve3000 content is personalized and adaptive based on learner Lexile growth & grade level. It assesses students, differentiates learning paths based on individualized needs, and drives acceleration through the proprietary engine that adapts text complexity as students are ready for a greater challenge. The program uses patented technology, including U.S. Patent # 8,714,986 for our proprietary adaptive differentiated instruction and embedded assessment, and U.S. Patent #9,652,993 for our proprietary process for differentiating content based on skill level. The key to the Achieve3000 differentiation method is that it ensures students receive text that is accessible to them, yet challenging enough to enable them to grow, ensuring they are always reading at an independent challenge level that optimizes



learning. Further, providing age-appropriate content for all students, regardless of their reading level, is what sets Achieve3000 Literacy apart from other programs.
