If a certified or cashier's check is used in lieu of the bid bond, a certificate from an approved surety company guaranteeing execution of 100% Performance Bond and 100% Payment Bond must accompany bid.

Scope of Project and Timeline: Tear off existing roofing, flashings and demo curbs as outlined on construction drawings. Loose lay type 2 base sheet over existing decking substrate. Mechanically attach R30 Polyisocyanurate Insulation. Adhere cover board in hot bitumen to Polyisocyanurate Insulation. Adhere modified bituminous base sheet and modified mineral cap sheet in hot asphalt. Install new wood nailers along perimeter and overflow scupper along each internal drain area. The timeline for this project is September 3rd 2019- November 4th 2019.

Bids: Before submitting a bid, each bidder will carefully examine the specification and other contract documents; will visit the site of work; will fully inform him or herself as to all existing conditions and limitations; and shall include in the bid the cost of all items included in the contract. **Bidders are required to use the bid tabulation form provided in this packet.**

Bond: A bid bond in the amount of five percent (5%) of the bid, made payable to the Board of Education of the Ogden City School District, shall accompany bid. If a certified or cashier's check is used in lieu of a bid bond, a certificate from an approved surety company guaranteeing execution of 100% Performance Bond and 100% Payment Bond must accompany bid.

Interpretation of Specifications: If any person contemplating submitting a bid for the proposed contract is in doubt as to the true meaning of any part of the specifications or other proposed contract documents, he or she may submit a written request on Sciquest.com for an interpretation thereof. Any interpretation of the proposed documents will be made only by addendum duly issued and posted on Sciquest.com

Addenda or Bulletins: Any addenda or bulletins issued during the time of bidding shall become part of the documents loaned to the bidders for preparation of his or her bid, shall be covered in the bid, and shall be made part of the contract, **and acknowledgment submitted in bid packet.**

Qualifications: The contractors and subcontractor's past performance, origination, equipment and ability to perform and complete their contract in the manner and within the time specified will be elements, along with the cash amount of the bid, which will be considered by the Owner in the letting of the contract. The contractor will comply with the license and bonding laws as required by the Local State Government. By submitting a bid, contractor also agrees to Ogden School District's Standard Terms and Conditions.

Withdrawal of Bids: Bids may be withdrawn on written or e-mail request received from bidders prior to the time fixed for opening. Negligence in the part of the bidder preparing the bid confers no right for the withdrawal of bid after it has been opened.
