Final Evaluation - August 6, 2021

The district's goal in this adoption is to provide research-based, relevant, and appropriate phonemic awareness and phonics instruction that will effectively support teaching and learning practices for our 1st-grade through 3rd-grade students who are falling below grade-level reading/literacy expectations.

Through this evaluation and selection process, the District aims to advance the Ogden School District Board of Education's mission, vision, and values by (a) increasing effectiveness of instructional practices, (b) providing print and/or technological assets that promote data-driven decision-making, and (c) streamlining access to progress-monitoring reporting tools.

On July 22, 2021, the district selection committee evaluated the General Requirements, System and Technical Requirements, and Agency Qualifications, Experience, and Support; but did not consider fee proposals. Based on the results of the initial evaluation, four respondents were brought before the full selection committee on July 30, 2021 and August 2, 2021 for formal demonstrations/ presentations. Following the presentations, the committee conducted a final evaluation and selected a solution for the Board's consideration.
