



Home School Affidavit

Home School Law 53A-11-102

Under Utah State law, a parent is required to enroll and send a school-aged minor (6-18) to a public or private school during the school year of the district in which the minor resides. A local school board shall excuse a school-aged minor from attendance, if the school-aged minor's parent files a signed and notarized affidavit with the school-aged minor's school district of residence, as defined in Section 53A-2-201. Students excused from attendance under this law shall be issued a *Certificate of Exemption from School Attendance* annually from their district of residence. (UCA §53A-11-101 and 102).

The undersigned and assumes sole responsibility for the education of the school-aged minor, except to the extent the school-aged minor is dual enrolled in a public school as provided in Section 53A-11-102.5 The undersigned parent expressly prohibits the release of any and all information contained in this document.
