



Home School Affidavit

Home School Law 53G-6-204

Under Utah State law, a parent is required to enroll and send a school-aged minor (6-18) to a public or private school during the school year of the district in which the minor resides. A local school board shall excuse a school-aged minor from attendance, if the school-aged minor's parent files a signed and notarized affidavit with the school-aged minor's school district of residence, as defined in Section 53G-6-302. Students excused from attendance under this law shall be issued a *Certificate of Exemption from School Attendance* annually from their district of residence. (UCA §53G-6-201 and 53G-6-204).

My decision to homeschool does not imply that the public school has not offered a free and appropriate public education. **I understand that my child will no longer receive services from the Ogden School District.**
